ORDER

University vide paper read (1) above invited applications for Continuation of Provisional Affiliation for the Academic year 2019-20 from colleges for courses affiliated to the University. The Principals of below mentioned Nursing Colleges submitted application and remitted required fee, for Continuation of Provisional Affiliation for the year 2019-20 .

2. The applications were processed by the University and Inspections were conducted at the Colleges. The reports submitted by the Inspection Commissions were verified by the Scrutiny Committee. The deficiencies pointed out by the Committee were intimated to the Colleges and the colleges have furnished the Compliance reports. After verification of the compliance report, the Scrutiny Committee recommended to grant Continuation of Provisional Affiliation to the Colleges for the Year 2019-2020.

3. The whole matter was placed before the 51st Governing Council meeting held on 01/03/2019. The Governing Council vide paper read (2) above **decided to grant Continuation of Provisional Affiliation to the Nursing Colleges for the courses and annual intake mentioned against each for the Academic year 2019-20 subject to receipt of renewal permission from the Central/State Councils .**

4. The colleges has produced renewal permission from Kerala Nurses and Midwives Council, Thiruvananthapuram for the Academic Year 2019-20. The Colleges reported that they have constituted College Council .

5. Governing Council vide decision 54.10 decided to grant Continuation of Provisional Affiliation for the year 2019-20 to otherwise eligible Nursing Colleges based on the approval from Kerala Nurses and Midwives Council and in anticipation of approval for such colleges from Indian Nursing Council. University vide paper read (3) above have implemented the above decision.

6. After considering the whole matter in detail, sanction, has, therefore been accorded by the Hon'ble Vice-Chancellor by implementing the decision No. 51.20 of the Governing Council to grant Continuation of Provisional Affiliation to the below mentioned colleges for conducting the courses with an annual intake of students mentioned against each during the Academic Year 2019-20 subject to the conditions detailed below:-

The General conditions are detailed below:

1) Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University/Govt. of Kerala and on the basis of the direction issued by the University from time to time, failing which the affiliation granted will be cancelled.

2) In the light of the direction of the Supreme Court of India in Writ Petition(c) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the College will be initiated.

3) Affiliation granted is strictly provisional and only for the academic year 2019-20. The college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex bodies concerned.

4) The Colleges should remit annual administration fee fixed for UG courses for the academic year 2019-20.

5) Admission to the next academic year shall be made only after obtaining prior permission from the University.
